Kuv yuav tsum ua li cas yog kuv yog ib tug koom Intensive Supervision Appearance Program (ISAP) thiab muaj sij hawm teem rau ICE check-in?

- Yog koj yog ib tug koom qhov Intensive Supervision Appearance Program (ISAP), tsis tas koj tus kheej yuav mus ntsib lawv. ISAP mam hu hauv xov tooj xwb.

Yog kuv yog ib tug koom ISAP tiam sis mus tsis tau qhov sij hawm teem rau ICE check-in ne?

- Yog koj yog ib tug koom ISAP tiam sis yuav mus koom tsis tau li teem tseg, koj yuav tau hu mus rau tus tuav koj cov ntaub ntauv es sau cia cov hnuv thiab sij hawm uas koj hu mus rau nws. Yog nws tsis teb xov tooj, thov tso koj lub npe, tus A-number, thiab koj tus xov tooj.
